## Jersey to the EU Pet Travel Animal Health Certificate Request Form

In order to travel from Jersey to the EU, unless your pet has a valid EU passport, we will need to issue your pet an Animal Health Certificate. Please complete this form and return it to us in advance of your appointment. Please make sure you tick the declaration at the end.

On the day of your appointment, we need you to bring proof of **valid** rabies vaccination (administered at least 21 days prior to the date of travel), and proof of identification of the pet. If you have a Pet Passport for your pet that was issued before 31/12/2020 this will suffice. If you do not have a Pet Passport for your pet then please bring your vaccination card that shows the current rabies vaccination, and any documents confirming your pet has been microchipped.

### **Tapeworm Treatments**

Tapeworm treatment is required when dogs are travelling from Great Britain (including Jersey) to EU listed tapeworm free countries including Northern Ireland, Malta, Ireland, and Finland, and Norway. These dogs must be treated for tapeworm not more than 120 hours and not less than 24 hours before time of entry into one of these countries. Please select from one of the following options (not applicable to cats/ ferrets).

Before returning to Jersey or elsewhere in Great Britain dogs must be treated for tapeworm not less than 24 hours, not more than 120 hours prior to your arrival time in Jersey (except for return from Northern Ireland, Malta, Ireland, Finland, or Norway). You must take your AHC with you for this treatment to a vet in the EU country you are in. However, if you are going from Jersey on a short trip returning within 120 hours, you can have this treatment done before leaving.
